

Peter T. Ricketts, *Les poésies de Guilhem de Montanhagol, troubadour provençal du XIII<sup>e</sup> siècle*, Toronto, Pontifical Institute of Medieval Studies, 1964. Montanhagol fue el gran propagandista de los valores corteses, defensor de los occitanos contra los cruzados y seguramente exiliado en España.

Martín de Riquer, *Los trovadores. Historia literaria y textos*, Barcelona, Planeta, 1975. Gran antología de la poesía provenzal (371 poemas de un total de unos 3200 conservados) con magníficos comentarios y traducción al castellano, muy didáctica; es la mejor aproximación a esta poesía.

Sergio Vatteroni, *Il trovatore Peire Cardenal*, Modena, Mucchi Editore, 2013. Edición crítica de la poesía completa de este trovador, prolífico y complejo.

Sergio Vatteroni, *Falsa clergia. La poesia anticlericale dei trovatori*, Alessandria, Edizioni dell'Orso, 1999. Magnífico estudio de la poesía anticlerical de los trovadores desde sus precedentes latinos y su constitución retórica.
